

Terms of Use Agreement

Lifenaut.com ("LN" or "we") is an online networking and personal data storage service designed to test the hypothesis that conscious analogs of people can be brought to life based on sufficiently detailed mindfile data, and to enable people to store information such as text, files, images, photos, video, sounds, musical works, works of authorship, medical/health/genetic records, and other materials (collectively, "Content"), and to share such Content with the general public. The services offered by LN include the LN website (the "Site"), and any other features, content, or applications offered from time to time by LN in connection with the Site (collectively, the "LN Services"). The Site and the LN Services are owned by Terasem Movement Foundation Inc. ("Terasem"), a 501(c)(3) not-for-profit charity endowed for the purpose of educating the public on the practicality and necessity of greatly extending human life, consistent with diversity and unity, via the geoethical application of nanotechnology and personal cyberconsciousness.

This page states the Terms of Use Agreement ("Agreement") under which You may use the Site and the LN Services offered on the Site. Please read this page carefully. IV. Rights and Responsibilities Regarding Content Posted on the Site or Through LN Services

a.) License for Content Submitted to Lifenaut.com
